Debbie was raised in Puerto Rico and moved to Georgia to attend Berry College in Rome, GA where she earned a Bachelorof Science degree with a major in Business and a minor in Economics. She opened and ran her own Mortgage Company for 16 years before she became the Executive Director/CEO of the Auditory-Verbal Center, Inc.

As a single mom of two children who were born profoundly deaf and graduated from the Auditory-Verbal Center, she found her passion in reaching out to all children who are deaf or hard of hearing to help them learn listening and spoken language and to become independent communicators. Since then, she has taken the Auditory-Verbal Center to new levels in moving to a bigger location, opening a satellite office in Macon, GA, and starting the Teletherapy Program. She is currently working on opening another location in Augusta, GA. Debbie is a member of the Alexander Graham Bell Association, Georgia's Early Detection, Hearing, and Intervention (EDHI) Advisory Committee, Georgia Pathway to Literacy Program, and a member of the Georgia State Board of Hearing Aid Dealers and Dispensers.

Debbie was a Girl Scout Leader for 9 years and Service Unit Director for 11 years before joining Kiwanis.

Debbie joined the Kiwanis in 2003 and has since served as several officer positions including, President, Secretary, and Lt. Governor. Debbie served as Governor for the Georgia District for the 2018-19 Kiwanis year. She also chaired on several Georgia District Committees such as the Buck-n-Ear Program, Community Service Committee, Criminal Background Screening Committee, Training Committee, Finance Committee, and International Convention Committees (TX and IN), and several others. Debbie currently has a triple membership in Kiwanis Club of Brookhaven-Chamblee, Kiwanis Club of Doraville-Tucker, and Kiwanis Club of Stone Mountain. Dear Friends of the Auditory-Verbal Center, Inc.

We are proud to present to you the Auditory-Verbal Center's Annual Report representing the financial results for Fiscal Year 2022.

About 2-3 of every 1,000 children in the United States are born with a detectable hearing loss in one or both ears. More than 90% of these children are born to hearing parents. With no family history of hearing loss, how would you feel or what would you have done?

For 46 years, we have focused our efforts on our core vision to "bring people who are deaf or hard of hearing into a lifetime of listening and speaking". We teach deaf or hard of hearing children to listen and speak through Auditory-Verbal Therapy and we guide and coach their families to be their primary language role models. Our therapists are trained to develop the listening pathways in a child's brain, laying the foundation for a lifetime of listening and speaking without the need for sign language or lip reading. We also have 4 bilingual therapists so we are able to provide intervention in Spanish for our Spanish-speaking families!

The window of opportunity to learn spoken language after birth is very short, which is why we didn't stop serving our clients due to COVID. We transitioned 100% of our clients to Teletherapy so they could continue to receive the services they needed and not fall behind. Since then, some have returned to in-person sessions but most have stayed as Teletherapy.

#### Here are some highlights from 2022:

Served 177 clients in our therapy program
Provided 3,636 therapy sessions
Served low-income and uninsured families, which is 65% of our caseload
Enrolled 61 new clients
Graduated 14 clients
Provided \$1,027,833.25 in scholarships and insurance discounts

In support of our continued growth, we have increased charitable contributions and maintained our limited state funding. We have strategically grown our Board of Directors and seek to address business continuity going forward. We also have an Advisory Board and a Board of Young Professionals to help fundraise and advocate in an effort to reach out to more supporters.

As always, we need more active board members and supporters. As you review this report and our continued success, we hope you will become involved. We would greatly appreciate your time and financial support!

#### **AUDITORY-VERBAL THERAPY**

Auditory-Verbal Therapy program that teaches deaf and hard of hearing children to listen and speak *without* the use of sign language or lip reading



#### **AURAL REHABILITATION**

Aural Rehabilitation program is for recent cochlear implant recipients, who already have established spoken language skills. Age 16 years and older.



#### **TELETHERAPY**

Auditory-Verbal Therapy and Aural Rehabilitation conducted virtually at a local TeleHealth Center or an approved venue



#### **AUDIOLOGY & HEARING AID CLINIC**

Identification, assessment, and treatment of hearing disorders for both pediatrics and adults




### **PROFESSIONAL TRAINING**

Program for graduate students and practicing professionals to gain university credit and clinical clock hours towards graduation





#### **AUDITORY-VERBAL THERAPY CLIENTS SERVED**



# **Teletherapy Moments**

Whether therapy is in-person or via Teletherapy, we know how to make learning FUN!



**KIYOMI** got to feed her baby doll a piece of banana she cut up to practice function words 'cut' and 'eat' while also learning to follow directions in play!

**CHARLIE** had fun working on a language experience around smells as they sorted things into "things we like" and "things we don't like" (and things that smell good and things that smell yucky).







**YAHSHUA** got to practice talking in sentences about the different animals who were so cold and frozen in ice! He loved helping the animals escape by pouring hot water on the ice and melting it, as well as hammering it off!

**JOSHUA** had lots of fun during teletherapy making spring handprint flowers as they practiced function words in Spanish such as "echa" (pour), "sucio" (dirty), "pinta" (paint), and "mas" (more)!





MAX loved making mini-pizzas during his teletherapy session with his Mom and Dad. Max had plenty of opportunities to practice past tense verbs and plurals as well as asking the question "how many/how much?". Teletherapy allows his AV therapist to be right in the family's kitchen and use materials that they have at home.

## **Graduate Spotlights**

In 2022, we graduated 14 clients who are now independent communicators in mainstreamed classrooms. Here are a few...



Tristan has been listening through binaural hearing aids since he was 8 months old. Over the years he has developed into a strong listener and communicator, and he will be attending a mainstream 3rd grade class this year. Tristan is an avid reader and reads on grade level. Tristan has a great sense of humor, and has learned to keep trying his best when he's faced with a new challenge. Tristan will be missed at AVC, but now he has more time to play games with his brother, Everest, and go on adventures with his family.



Briana is a 3-year-old girl with moderate hearing loss and wears hearing aids, just like her younger brother. In just 6 months, Briana progressed from having severe language and moderate articulation delays to now scoring well within normal limits in her home language of Spanish. All of Briana's therapy was conducted via tele-therapy due to the pandemic and transportation barriers. Briana is excited to start preschool next fall and learn English, alongside typical hearing peers. Briana is creative, independent, and bright. She loves singing and making crafts with her mother and cousin. Her favorite song is "La vaca lola"!



Marlee has worn bilateral cochlear implants since she was a year old. She and her parents have put in a lot of hard work over the years, and it shows! No one has ever accused Marlee of being shy, and she always comes to therapy with new stories, new ideas, and new topics of conversation to discuss with her therapist. Marlee loves to read, sing, dance, swim, do gymnastics, and play with her brothers. She will be attending a mainstream first grade class this year, and her future is bright!



Olivia was born profoundly deaf, just like her older sister. Olivia and Emily both hear with bilateral cochlear implants and share a unique bond over their special ears. Olivia received her first cochlear implant at 6 months of age and was one of the youngest babies to ever be implanted in the state of Georgia. Olivia loves talking, singing, and painting. She thrives in her mainstream preschool classroom. Olivia's family lives over 2 hours away from AVC and almost all of her therapy has been provided via tele-therapy, right from her home!



BASED ON THE 2022 BUDGET OF \$1.7 MILLION




